SECTION V-F. COMMITTEE ON STUDENT LIFE, SERVICES, AND ENVIRONMENT.

V-F: Par. 1. *Membership.* The Committee on Student Life, Services, and Environment shall have the following membership: the Provost, *ex officio*; the Vice President for Student Affairs or officer of equivalent jurisdiction, *ex officio*; the Dean of Undergraduate Studies, *ex officio*; the Director of Athletics, *ex officio*; six voting members of the University Undergraduate Faculty; four undergraduate students; and one graduate student from a degree program in one of the constituent faculties.

V-F: Par. 2. *Selection and Representation.* The six voting members of the University Undergraduate Faculty shall be appointed by the Executive Committee. The Vice President for Student Affairs, or officer of equivalent jurisdiction, shall designate the student organization or group to select the student members and the method of selection. Each of the following groups shall have one student member: (a) North Campus residents, (b) South Campus residents, (c) Greek Letter societies, and (d) commuting students. The graduate student member shall be selected by the Graduate Student Senate.

V-F: Par. 3. *Terms of Membership.* The term of membership on the Committee on Student Life, Services, and Environment of each of the six voting members of the University Undergraduate Faculty shall be three years to be served in rotation, the initial terms to be determined by lot for periods of one, two, and three years respectively. A member of the University Undergraduate Faculty may not serve two immediately successive terms on the Committee, but, following a lapse of one year after the end of his/her term, he/she may again be appointed to Committee membership. The term of membership of a student member shall be one year. Student representatives shall be eligible to serve for successive years for the duration of their status as a student in good standing in the constituency they represent.

V-F: Par. 4. *Chair of the Committee.* The Executive Committee shall designate one of the six members of the University Undergraduate Faculty named for membership on the Committee on Student Life, Services, and Environment as Chair of the latter committee. The Chair shall serve for the duration of his/her membership on the Committee. He/She shall preside at all meetings of the Committee and shall transmit all reports and recommendations of the Committee to the Executive Committee.

V-F: Par. 5. *Secretary.* The Vice President for Student Affairs shall serve as Secretary.
