Staff Advisory Council General Council Meeting Minutes

Thursday, June 15, 2023 @ 10:00am - 11:30am in the Toepfer Room and via Zoom

Welcome and Call to Order at 10:03 am by Ray Krajci (Dawn Ellis was excused for illness).

Housekeeping: Ray reminded everyone that the General Council had voted to adopt the Democratic Rules of Order at the last General Council meeting, so that would be used for this meeting. The SAC Constitution had also been amended to reflect this change.

Minutes approved without amendments.

New Business

• There was a motion to amend Article VI of the SAC Constitution by replacing the text "Senior Vice President" with "General Council". Jim Nauer seconded the motion and it passed with unanimous support.

Old Business

• Raymond Krajci reminded everyone of the issue up for a vote: whether or not to return to fully in-person General Council meetings for 2023-24. A discussion followed with several comments:

-hybrid meetings allow more people to attend the meetings

-it works better for the hybrid work schedule that most staff have (some people office share)

-it is difficult for those on the HEC campus to get to meetings in Adelbert -it is good to have accommodations for those with different physical abilities or injuries

-it would be best to hold the meetings in person, so it would be good for people to attend in person if they are able, even if Zoom is an option

Following the discussion, the vote occurred.

Vote to hold all 2023-24 General Council meetings fully in person to Adopt the Democratic Rules of Order

85.7% voted against The motion was defeated.

There haven't been any meetings and committee members have not had a voice in any of these decisions.

Announcements from the Executive Committee

- The Executive Committee met with the President and Provost. The President is focused on two priorities: 1) Building trust and transparency and 2) The supervisor/supervisee relationship. SAC should be thinking about how we can respond and or contribute to the conversations about those priorities.
- The Executive Committee met with Carolyn Gregory and discussed the recent Student Affairs reorganization. From the HR perspective things have gone about as well as they could. There may be changes to the hybrid work rules surrounding those staff members working in student facing positions. There will be a 2% wage increase in July to account for cost of living increases. This does not apply to those hired after April 2023. They are also planning for a 4% merit pool for this year. Information should be coming soon. Several people mentioned that this was a refreshing change.
